The Mayor and City Council met in Regular Session on Tuesday, May 16, 2017 at 5:00 p.m. in the Court Chambers of the Municipal Complex. Mayor Robert E. Smith, Sr. presided over the meeting, and all Council Members were present, with the exception of Council Member Gavin, who was absent.
